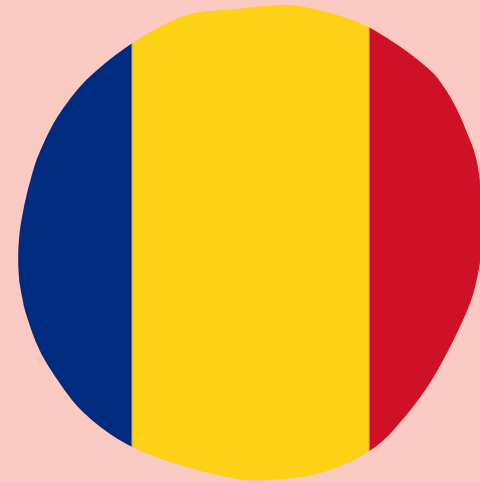

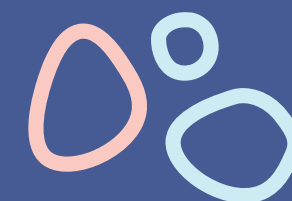

## DESCRIPTION OF THE PROJECT

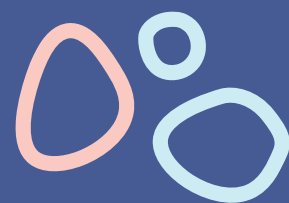
Youth workers are working not only with intact (healthy) youth but also with disabled young people who are keen to learn and participate as their peers, just with using different methods. By this project we will address the issue of low participation of young people with disabilities (YPD) in the non-formal activities with the terms of the same opportunities as others (intact youth) and in terms of their inclusion to the society. Youth workers will learn how to involve, work and help to YPD. They will improve their knowledge and skills how to manage, adjust and create new non-formal activities for YPD. Lack of information and practise prevent youth workers to involve young people with disabilities in their local, national and international activities. By this project we will share the good practises and will learn youth workers how to use and also create new and direct non-formal activities which they will be able to use in their daily work.

## THE MAIN OBJECTIVES OF THIS PROJECT ARE:

- Raising awareness among young workers that the disability is one component of the life of YPD, not the only component.
- Through different activities make youth workers realize what obstacles YPD are facing and what is the weak points in their inclusion.
- To gain new knowledge how to work with YPD and in what content should the activities take part.
- Learn youth workers how to use the non-formal activities in the youth work with YPD.
  - To promote inclusion, respect, harmony, tolerance, acceptance and global understanding among people with disabilities.
- To create and develop the Handbook with adapted and new non-formal activities which can be used for youth work with YPD.



# PARTICIPANTS



## **FEWER OPPORTUNITIES**

We want to focus on the youth workers who are facing any kind of economic, social, geographical obstacles or cultural differences as well as youth workers who are disabled or having a serious health problems. We expect each organization to delegate one from three such participant.

The participants of the training will be selected with an open and transparent procedure by respecting the inclusion of fewer opportunity target groups and the gender balance of the activities. Participants of the training course will be youth workers, youth leaders, trainers, specialists, activist with and/or without experience in mental, physical, hear-loosing and blindness disability related issues that are motivated to act as future advocates for the topic in their own communities and are able to transmit the learning to their peers, especially those in rural areas. Our working language will be English so all participants should be well informed about the language level which is required.

**All participants need to fill in the application form.**

**Each organization will send 3 participants (18+ years old):**

- **one beginner in youth field with no experience but with strong interest in the topic;**
- **one specialist who has work experience with disabled people;**
- **one directly involved in the youth work of the partner organizations.**

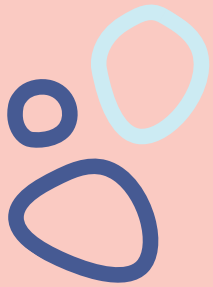

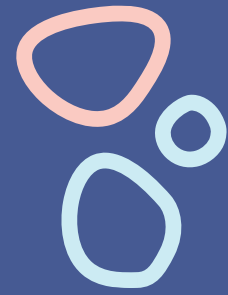
Mobility of youth workers

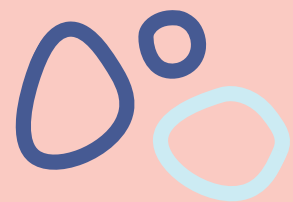




# ACTIVITIES

THROUGHOUT THE PROJECT, PARTICIPANTS WILL CONDUCT A VARIETY OF NON-FORMAL LEARNING ACTIVITIES. ALL ACTIVITIES WILL BE CONDUCTED BY THE PARTICIPANTS IN GROUPS WHERE EACH COUNTRY WILL BE REPRESENTED AND WILL BE PRESERVED GENDER EQUALITY. IN ORDER TO MAKE THE PROJECT VISIBLE, SOME OF THE TASKS CONSIST THE PREPARATION PHASE. THIS ALSO HELPS PREPARE THE PARTICIPANTS THEMSELVES. **DURING THE MOBILITY, PARTICIPANTS WILL ALSO WORK ON THE HANDBOOK WITH ADAPTED AND NEW NON-FORMAL ACTIVITIES WHICH WILL BE USED FOR YOUTH WORK WITH YPD.** ALL NECESSARY MATERIALS WILL BE PREPARED BY HOSTING TEAM.





# Reimbursement



## TRAVEL BUDGET

Travel costs will be reimbursed to the sending organizations' bank accounts upon the receipt of all the justification documents and only if all the needed documents have been sent to the coordinating organization.

**THE TRAVEL DAYS ARE 3RD AND 10TH NOVEMBER 2019.**

Reimbursement includes also local transportation costs (but not private transportation). The cheapest means of transport should be used.

**YOU HAVE TO TAKE OUR CONFIRMATION BEFORE BUYING YOUR FLIGHT TICKETS.**

Any change of the arrival and departure days as set in this document should be not made without prior permission of the coordinating organization. Participants are allowed to travel 2 days before or after the project only if the option is economic and confirmed by the coordinating organization. Free time tickets which are not direct to the project place or extra services and classes will not be reimbursed. The entire duration of the project must be followed by each participant. Arrival documents must be given to the coordinating organization during the mobility of youth workers and all the rest sent by email (if online) and by post after the project (the returning documents must be firstly scanned to the coordinating organization and then sent by post).

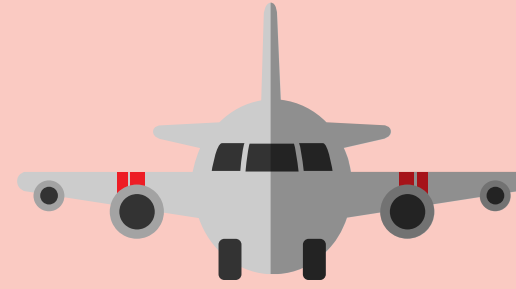

# Important Info

THE SENDING ORGANIZATIONS WILL PROCEED A VISA (IF REQUIRED) AS WELL AS HEALTH INSURANCE CARD (VALID IN SLOVAKIA),

- A COMMON ETHICAL CODE WILL BE FOLLOWED BY EACH PARTICIPANT IN ORDER TO AVOID ANY DISCRIMINATORY OR BAD TREATMENT,
- PARTICIPANTS LIST WITH CONTACTS, ARRIVAL AND DEPARTURE TIME OF EACH PARTICIPANT WILL BE MADE BY ORGANIZATIONS AND WILL BE SEND TO PROJECT MANAGER OF THE PROJECT,
- PLACES FOR ACTIVITIES WILL MEET HYGIENE AND SAFETY REQUIREMENTS IN ACCORDANCE WITH NATIONAL AND EUROPEAN STANDARDS, - EACH ORGANIZATION WILL HOLD MEETINGS WITH THE PARTICIPANTS TO PREPARE THEM

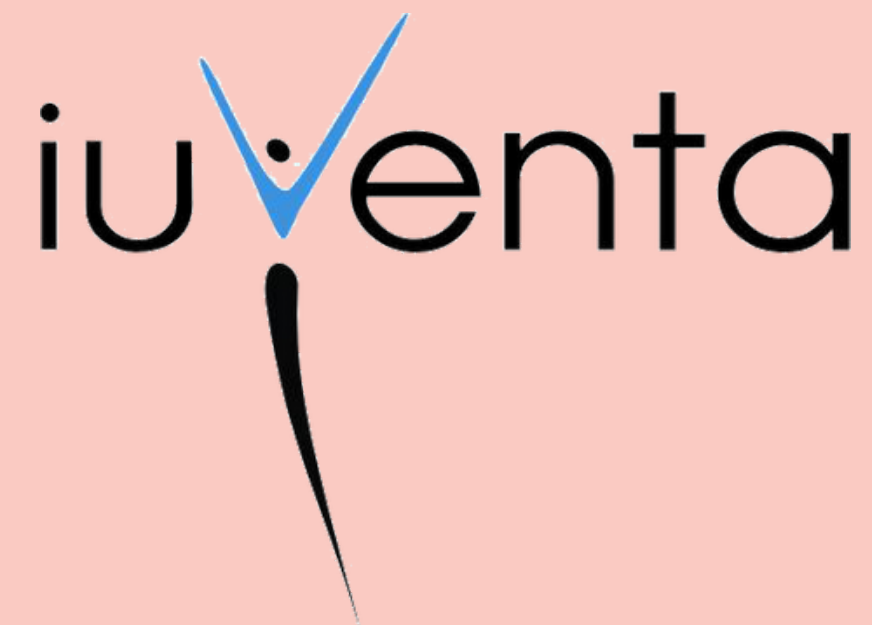

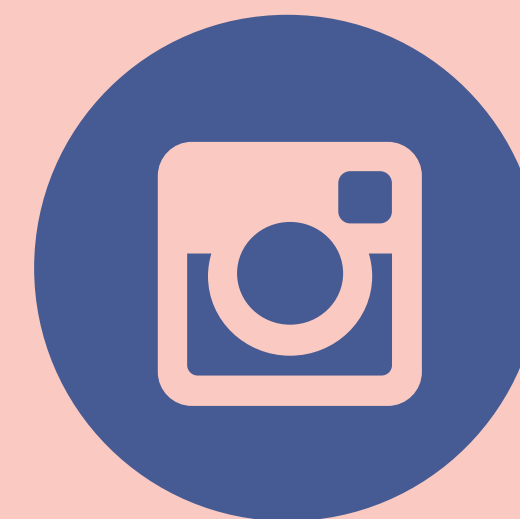
